We need copies of your passport and Danish national health card/proof of residency because we need to verify your identity. You must send these to us by ordinary mail because sending a copy of a passport by unencrypted e-mail is not secure enough.

- Please note that it can take up to 30 days from receipt of your request until its processing has been completed.
- You will then receive your result by ordinary mail to the address specified in your contact details.
